Terms and conditions for the Course Coordinator to be engaged

1. **Period of engagement:** The period of engagement under this offer shall be for a fixed period w.e.f. 10.01.2025 to 30.06.2025 in Central Sanskrit University, Lucknow Campus.
2. **Remuneration:** The Candidate will be entitled for a fixed consolidated and an all-inclusive remuneration @Rs.50000/- (Rupees fifty thousand only) maximum per month.
3. **Medical Fitness Certificate:** The Candidate will have to produce medical fitness certificate from the Registered Medical Practitioner certifying that he is medically fit for rendering his services in the University.
4. **Leave:** The Candidate will be entitled for 04 days casual leave per semester on prorated basis for the said period of engagement and will not be entitled for any other kind of leave.
5. This engagement is made purely on temporary and contract basis for fixed period.
6. The Candidate will not be entitled to any other benefit such as Confirmation, LTC, Medical reimbursement, etc. which is admissible to the regular employees of the University.
7. The Candidate will have no claim for regularization/seniority on the basis of this engagement.
8. The University reserves the right to terminate this engagement any time even before the stipulated time, without assigning any reason.
9. The Candidate will have to perform the teaching and other duties as assigned by the Director of the Campus which is subject to review time to time.
10. The Candidate will be required to engage classes in the Campus as per its requirement in accordance with the directive of the Director of the Campus.
11. During the tenure of the above engagement, the Candidate will not engage himself in any other assignments or gainful employment.
12. The Candidate will have to submit an undertaking that he will not indulge in any activity which is illegal or is subversive of discipline or detrimental to the academic atmosphere of the Campus and that he will abide by the rules and regulations applicable to the University and its employees without claiming other benefits than prescribed in above terms and conditions.

Prescribed qualifications for the Course Coordinator to be engaged are as follows:

- i. Acharya/M.A.(Sanskrit) or equivalent degree in the concerned/allied/relevant discipline, with atleast 55% marks (or an equivalent grade in point scale wherever the grading system is followed) from an Indian University or, an equivalent degree from an accredited foreign university.
- ii. The candidate must have cleared the National Eligibility Test (NET) in the concerned/allied/relevant discipline, conducted by the UGC or the CSIR, or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfilment of the following conditions: -

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
 - b) The Ph.D. thesis has been evaluated by at least two external examiners;
 - c) An open Ph.D. viva voce of the candidate has been conducted;
 - d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
 - e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.
- iii. Ability to work/teach through Hindi and or Sanskrit and or English medium.
